1-PROJECT OVERVIEW:

(Summary of general information about the project)

The **Company Adelino Rodrigues Martins, Limitada**, holder of the Unique Tax Identification Number (NUIT) 401123555, legally dedicated to the production and sale of agricultural products and the production, processing and sale of soybeans and corn, based in Carapira, Monapo District, at Nampula Province, Republic of Mozambique, proposes to implement 3 projects, namely, the production and sale of soybean meal, corn and its derivatives as well sweet potatoes, in a total area of 1,100 hectares, from 1720 available hectares, distributed thus:

- Soy Flour (900 hectares) estimating to produce 2,625 tons and 700 tons of bran (annual);
- Cornmeal (100 hectares) for a production of 2,815.50 tons and 750 tons of bran (in 3 cycles per year); and
- Sweet Potato (100 hectares) expecting to produce 7,000 tons (in 2 cycles per year).

To materialize the above mentioned wishes, the Company needs 94,546,885.22 MT (**equivalent** to 1,276,453.15\$), distributed as follows:

In addition to its own production, the company plans to integrate 400 local producers, in form of fomentation, 200 of which soy production, 100 in corn, and the same number in the production of sweet potato. Thus, the Company intends to act as a **Commercial Producer (Integrator)**, where it will provide 300 hectares of arable land, agricultural inputs, and the necessary technical support throughout the production process. With this initiative, the Company intends to guarantee income and employment generation for these producers and their respective families, and in this way, contribute to the development of Monapo District (in particular), Nampula Province and the country in general.

With special emphasis goes to the project of production and sale of soy meal, where 45.119.700,00MT (=609.149,45\$) will be necessary for the production of 2.625 tons of soy meal and 700 tons of bran, in an area of 900 hectares, being able to destine the amount of

11.137.711,11MT (=150.363,37\$), equivalent to 22,22%, for the productive process of 200 local integrated producers in a production area of 200 hectares.
The idea for these projects in allusion occurred because there is a national shortage of producers of soybean (TGX variety), corn (PAN 53) and its meals, and sweet potato that offer high quality products and, at the same time, there are no large-scale producers located near the region where the activities will be developed, the reason that generates an investment opportunity in these agricultural segments.
