Province of Nampula, in the districts of Nampula, Monapo and Mecuburi.

District of Nampula: Administrative Post of Anchilo, village of Matibane.

Monapo District: Posto Administrativo Sede, in the Regulated Region of Carapira

Mecuburi District: Administrative Post of Namina, Ratane locality

3. Reasons for Choosing the Site

Given the agricultural production and productivity of the areas referred to above, coupled with the lack of a mill to install the products, they are one of the reasons for setting up community mills.

4. Justification of the Project

On the one hand, a greater number of women are elderly and do not have the capacity to continue to transform their products, using traditional methods. On the other hand, with the installation of

community mills they will be able to ensure the generation of income for the survival of the elderly, taking into account, with the policy of creating social assistance boxes. This is to benefit the most vulnerable elderly.

5. Project Objectives

- 1. Generate income for the self-support of the elderly, reducing begging;
- 2. Improve the diet of elderly people;
- 3. Ensure the operationalization of the social assistance fund

6. Duration of the Project

The project will last for 12 months (1 year).

7. Beneficiaries of the project

The Project will benefit the elderly and vulnerable children

Indirect beneficiaries

The entire population residing in the region where the Project is

- 1. In the village of Matibane, there are over 2 thousand inhabitants, of whom 1300 are elderly people;
- 2. In Carapira, around 1200 elderly people out of more than 6 thousand inhabitants live;
- 3. In the locality of Ratane, more than 3 thousand inhabitants live, of which 450 are elderly people.
